






Comparison of Expenses 2018 - 2020

In 2020, branches spent a total of \$ 25,187 of BCIA funds for branch related functions and professional development. This was 65% of the branch allocations for 2020. This result is from branches not being able to hold in-person events due to Covid-19 restrictions. Branches were able to hold webinars and virtual sessions, but the costs associated with most of those events were significantly less than holding traditional in-person events.
