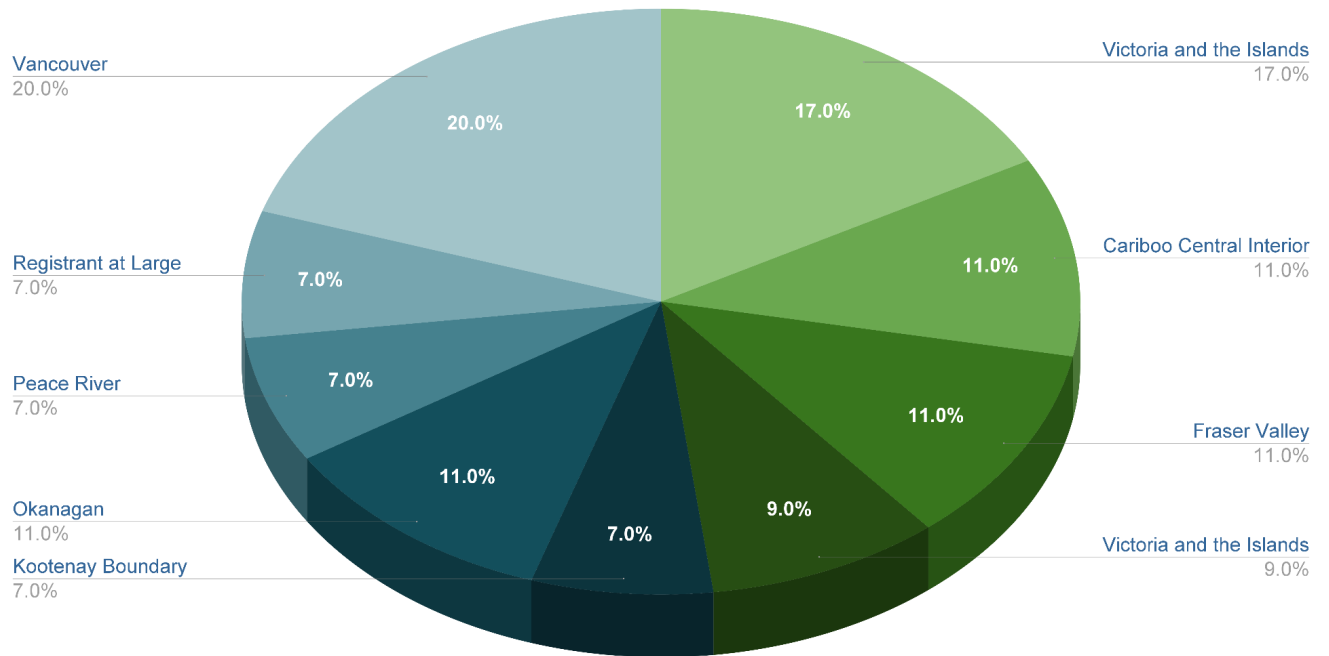

Employment Sector

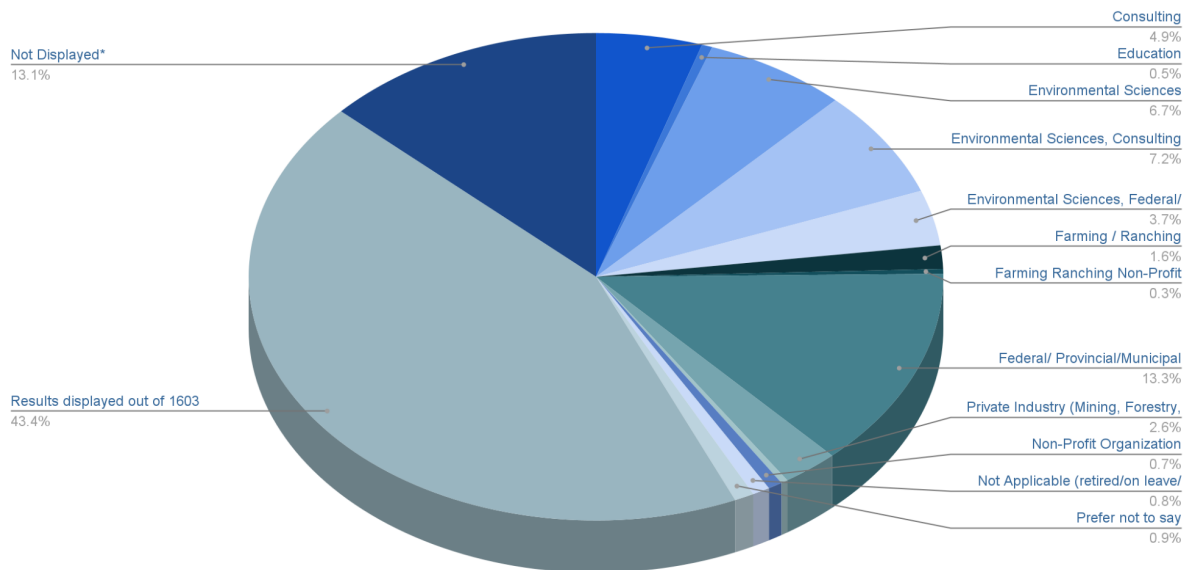
This question allows participants to make multiple selections, resulting in 108 combination categories. To keep the standard error to a minimum and represent the sample range with smaller confidence intervals, only 1231 entries out of 1603 result counts were chosen to present the statistical information shown below.

The results from cluster selections of employment sectors that make up less than 1% of the total count and subgroups under Environmental Sciences and Farming/Ranching Sectors are not included in the pie chart. Please refer to Appendix 1 for full results.

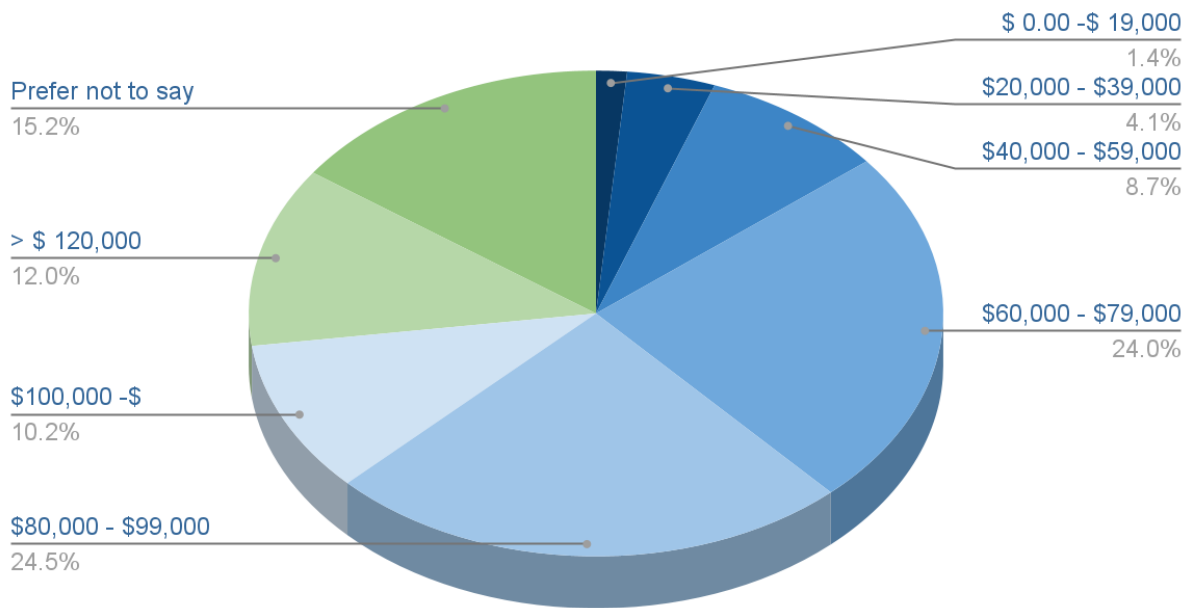

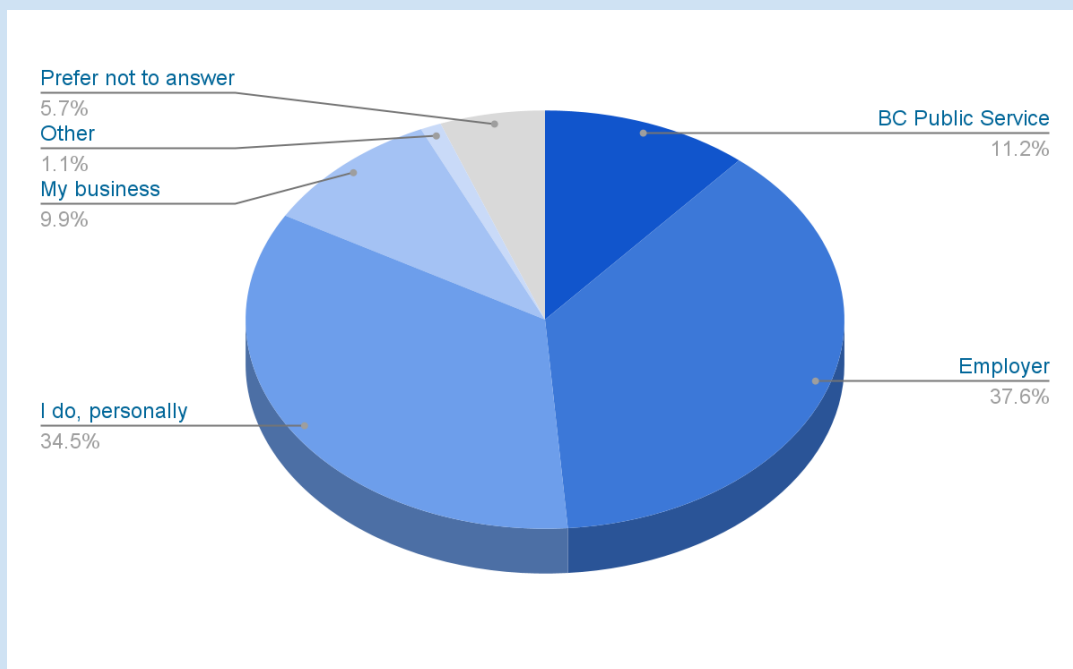

Standard error measures the accuracy of a statistic taken from a sample representing an entire population. The smaller the standard error, the more representative the sample will be.

Confidence intervals provide a range of values close to the estimate, within which the actual value can be expected to fall. The smaller the confidence interval is for a particular estimate, the more precise the estimate is.
