Experience includes different drilling techniques (rotary, direct push, and diamond drilling in both soil and bedrock), test pitting, various contaminants of potential concern (hydrocarbons, heavy metals, chlorinated solvents, salinity, and buried waste such as Agent Orange, management of health and safety on site, sub-contractor supervision, client/site management liaison including conducting site meetings with regulatory bodies, and supervision of 'off-site' borehole drilling on third party properties.

#### **Site Remediation/ Facility Upgrades**

Currently managing multiple complex legacy sites in northern BC, including High-risk sites that have been successfully removed from the registry. One of these sites is located in a mixed commercial / residential area surrounded by drinking water wells. The management of this site involves a team of specialists (Contaminated Sites Approved Professional, Principal Hydrogeologist, Remedial Engineer, Risk Assessor and Field Coordinator). A large-scale groundwater containment/treatment system was conceptualized, constructed and installed at the site for the purpose of capturing and treating impacted groundwater and to prevent contaminant migration to drinking water wells near the site. Multiple pilot programs have been conducted at the site, including the use of electrokinetic technology, pneumatic emplacement (fracturing), and nutrient injection to evaluate the effectiveness of remediating hydrocarbons in clay soils.

#### Project Manager / Senior Technical Advisor

Rebecca has managed the permitting process for over 15 Waste Discharge Authorizations issued through the BC ENV and over seen the commissioning of several remedial systems in complex mixed-use locations (industrial/commercial and residential neighbourhoods, etc.). System have been designed to reduce the hydrocarbon concentrations in soil and groundwater at the site of both operational and decommissioned downstream oil and gas sites where the plumes extend across multiple utility rights-of-way (including a high-pressure natural gas main), city, regional and provincial road rights-of-way and multiple residential properties (many with drinking water wells).
